### Proposed Interior & Renovation for Sri Lanka Institute of Development Administration

The Chairman, Departmental Procurement Committee on behalf of the Sri Lanka Institute of Development Administration invites sealed bids from qualified bidders for Proposed Interior & Renovation works for Sri Lanka Institute of Development Administration, as described below and estimated cost is Rs.4.2 million approximately.

The bidder is advised to visit SLIDA and be acquainted and familiar with the situation and the extent of the work before pricing. The work comprises the windows, interior, MEP, finishes and other related works.

- 1 Bidding will be conducted through the National Competitive Bidding Procedure.
- 2 The contractor must be able to complete contract within 90 days from the date of confirmation.
- 3 To be eligible for contract award, the successful bidder shall not have been blacklisted in the field.
- 4 Bidder should be a CIDA registered contractor under **C8 / SP4** or upper grade in the field of Building Construction. / Specialised Construction Contractors (SP-C).
- 5 Interested bidders may obtain further information from Director (Administration), Sri Lanka Institute of Development Administration, 28/10, Malalasekera Mawatha, Colombo 07 and can inspect the bidding document at the same address.
- 6 Bid document will be issued to each Bidder on the payment of a **non-refundable fee of Rs. 2,000/=**. Payment should be made in cash only, to the Shroff, Sri Lanka Institute of Development Administration **from 9.00 a.m. to 3.00 p.m. from 02.12.2024 to 19.12.2024. (Week days only)**
- 7 Bid shall be accompanied by a Bid Security which shall be:
  - In the form included in the Section 08 in the Bidding document
  - In favour of Director General, Sri Lanka Institute of Development Administration
  - For an amount of **Rs. 50,000.00**
  - Valid up to **17.03.2025**
  - Issued by one of the agencies indicated in the ITB Clause 16.0 of the Schedule
- 8 The contractor is required to study this bid document along with the SBD 03 document that was published by CIDA.
- 9 Contractor shall provide one year guarantee for all works.
- 10 A pre – bid meeting will be held **at 10.00 a.m. on 09.12.2024** at the Sanvadani Room, Sri Lanka Institute of Development Administration, 28/10, Malalasekera Mawatha, Colombo 07.
- 11 Bids should be sent **on or before 2.00 p.m. on 20.12.2024** by registered post in sealed cover addressed to the Chairman, Procurement Committee, Sri Lanka Institute of Development Administration, No.28/10, Malalasekera Mawatha, Colombo 07 or placed in the Tender Box kept in the office of the Director (Administration). Late bids will be rejected. Bids will be opened soon after closing time and bidder or their authorized representatives could be present at the opening of bids.
