2. If the total estimated cost of a proposed irrigation project under your Ministry is estimated to be approximately Rs. 1,500 million,
 - a) Identify the type of the project in terms of the classification of the projects and explain the approval process of such type of projects. (10 marks)
 - b) Explain the process you follow in preparing the total cost estimate in terms of F.R. 20 as amended by Public Finance Circular no 01/2019. (10 marks)

 - a) Explain the powers of Accounting Officers to incur expenditure in terms of F.R. 93 in relation to new construction work and projects. (10 marks)
