- ii. As mentioned in Volume II of the Establishments Code, name five (05) serious offences included in the first schedule of offences. (15 marks)
3. i. Name the officers who are not entitled to political rights according to the provisions of the Establishments Code. (06 marks)
- ii. What are the facts that should be mandatorily included in a disciplinary order? (14 marks)
4. i. What are the requirements that should be fulfilled for the payment of the combined allowance? (10 marks)
- ii. Name the facts considered for the payment of Settling-in-allowance. (10 marks)
5. i. Explain in brief the importance of a probation period for a public officer as mentioned in the Establishments Code. (14 marks)
- ii. Name three main facts that are evaluated through the annual review report submitted on the public officers during the probation period. (06 marks)
