### **GUIDELINES FOR ABSTRACT PREPARATION**

SLIDA welcomes original research work from researchers that have not been published or are under concurrent consideration for presentation elsewhere. The abstract should ideally fall under one of the seven themes. However, the Editorial Board reserves the right to change the theme of the abstract if deemed necessary.

Please follow the specified guidelines given below to prepare Abstracts.

### **GUIDELINES FOR ABSTRACTS**

**Word Limit**: 300 to 400-word abstracts should be submitted using **Times New Roman** (font size 12) / Single Space.

**Body of the Abstract:** Abstract must be written *ONLY in English*; figures, tables, equations, and references are not allowed. *If required, the source of funding of the research may be acknowledged by a single sentence.* 

**Content of the Abstract:** Abstract should have a short introduction, objectives, methodology, results, and conclusion(s) written as a single paragraph. It should not contain any sub-headings, figures, tables, equations, and references.

**Keywords**: A maximum of 5 (five) keywords should be included.

Please use the "Abstract Template" and prepare your abstract without changing the formatting.

### **MODE OF PRESENTATION**

Authors of all accepted abstracts should make their oral presentation at the symposium in *English*. The hybrid facility is available only for presenters who are abroad upon approval from the Symposium Committee.

### **REGISTRATION FEE**

The text of the abstract should be written in this section. Abstract must be prepared in English, using MS Word 2007, 2010 or Word 2013. Paper size is A4, line spacing is single and page is justified. Please use 12-point Times New Roman font. Each paragraph is indented with a tab. The entire abstract should fit on one page with one-inch margins on all four sides. There is a 300 words minimum and 400 words maximum limit for the body of the abstract. This word limit includes words in the title, names of authors, affiliations, acknowledgment and keywords. The suggested content in the abstract includes research background, research problem, methodology, significant findings and conclusions. The abstract should not include figures, tables, equations, and references; you should put these in the PowerPoint slides of your oral presentation. Please check your spelling and grammar very carefully. Title of the abstract should be short, specific and reflect the study carried out, and should be in uppercase and bold letters. Authors' names will carry initials and surname, and should be centered. Initials of the authors must be in uppercase letters and indicated before the surname. Capitalize the first letter of Authors' surnames. Each initial should be followed by a full-stop without a space. Between the last initial and the surname, a single space should be placed. Presenter's name should be underlined and an asterisk at the end of the name should indicate the corresponding author's name. Capitalize the first letter of each word of the author affiliation and center aligned. Please use superscripted numbering of authors if authors have different affiliations. Affiliations should be on a separate line and numbered with the same superscript number used for the respective authors. Superscripted numbers should be positioned at the beginning of each affiliation and at the end of each author's name. E-mail address of the corresponding author should be provided after the affiliations. Abstracts that do not comply with this format, specifically the word limit or formatting of the authors' names and affiliations, will not be considered for publication in the proceedings and will be returned to the corresponding author for amendment. Authors are encouraged to use this template to submit their abstracts. They can simply paste the text of the abstract from their word processor to this template.

### Keywords: Abstract, Words, Format, Guidelines, SLIDA

Acknowledgement should be left justified. If necessary, please include the grant or other support information for your research in a single sentence (grant number should be in parentheses) at the end of the abstract. Place only one space between the body of the abstract and the acknowledgment.
